ADDENDUM

- i) Please read the definitions of Successful bidder as
"Successful Bidder is the Bidder who inter-alia meets the following requirements:
 - a) The Bidder who meets the Technical criteria as set herein; and
 - b) 'The bidder who emerges at the top of the list of bidders in financial evaluation quoting the lowest financial value in Financial Bid and adheres / consents to adhere to all other conditions laid down by TTDC in regard to the Job/Work' instead of existing definition as in page No.8 of the bid document.
- ii) Please read in the definitions of Tender as 'as 5 years' in place of '6 years' at page No.7 of the bid document.
- iii) Please read the Clause 3.7.1 as "The Bidder ranked at the top with the Lowest Financial Value as prescribed above shall be the Successful Bidder for the Job/Work" in place of existing text.
- iv) There was an email query regarding the requirement of both IS and ISO registration. In this connection, it has been clarified that the product must conform to the specifications laid down in IS: 15886-2010 as the same governs the product quality and the ISO certification shall be an additional qualification.
- v) Please read the Nomenclature of 8 Seater capacity Battery Operated Vehicle (BOV) as "8 Seater Bus Model" in place of "8 Seater Golf Cart Model".
- vi) Please read the period for completion of the supply as "40 days" in place of "1 Month".
- vii) There was an email query that whether the NSIC and MSME registered firm would get the exemption from submission of Demand Draft (DD) towards the cost of Tender Document, Earnest Money Deposit and the yearly turn over as set in the document. In this connection, it is clarified to stick to the provisions already set in the Bid document.
- viii) Please read EMD as Rs.77500.00 in place Rs.69000.00 as displaying in the box of the website.
