2. The vehicle/ car should have all valid documents having commercial license as per MV Acts.
3. The following documents (Photo copies) has to be attached along with the tender papers;
 - Date/ Year of Purchase.
 - Registration Card.
 - Fitness Certificate and Tax token.
 - Insurance paper and road permit.
 - PUC Certificate.
 - Screen report of the Vehicle.
 - Full details of the owner: To attach Voter ID and Aadhar Card.
 - Present KM reading on the date of Submission of quotation should also be attached in plain paper.
 - Fuel Type.

The tenderer will have to deposit an amount of Rs. 10,000/- (Rupees ten thousand) only as earnest money on the shape of Bank Draft/ FDR/ Deposit at call drawn in favour of the Managing Director, TTDCL Office, Swetmahal, Palace Compound, Agartala. Continuation of Terms and Conditions.

5. Providing fuel, towel, lubricants, dusters and maintenance including repairing and washing etc. for the vehicle will be the responsibilities of the owner/ supplier.
6. The vehicle should be placed within 07 (seven) days from the date of issue of the final order.
7. The supplier will be provide minimum accessories for the vehicle.
8. The driver should be given prescribed liveries by the suppliers.
9. In case of need, the driver has to be changed within 24 (twenty four) hours on being informed and if the vehicle / car is not available on any day no payment (Halt Charge) etc would be made for the day and also for the next day.
10. In case of repairing of vehicle a similar vehicle / car shall have to be provided by the supplier as replacement during the repair.
11. Payment of hiring charges will be on monthly basis against bill raised by the owner/ supplier supported by appropriate certificate from the user.
12. Taxes will be deducted from the bill as per rules.
13. The vehicle/ car shall be parked in the office of TTDCL, Swetmahal, Palace Compound, Agartala for security reason.
14. The hiring of vehicle shall be valid for 01 (one) year subject to extension of hiring on satisfactory service. However, the hiring may be discontinued by the TTDCL at any time without a short notice.
