


**A. EARNEST MONEY AND VALIDITY OF EXPRESSION OF INTEREST(EoI)**

- 1) Expression of Interest (EoI) shall be accompanied by the earnest money @ 2.5% of estimated value of EOI in the form of D-call/Demand Draft to be drawn from any nationalized bank of India in favour of **Managing Director, Tripura Tourism Development Corporation, Agartala, Tripura**, payable at Agartala, otherwise the EOI shall be liable to be treated as disqualified.
- 2) The Earnest money of the bidders other than 1<sup>st</sup> & 2<sup>nd</sup> lowest bidder shall be released after opening of EOI.
- 3) Successful bidder shall deposit 10% of EOI as security deposit in the form of Demand Draft of any nationalized bank of India in favour of **Managing Director, Tripura Tourism Development Corporation, Agartala, Tripura**, payable at Agartala, where in 2.5% earnest money shall be considered as a part of security amount.
