| 2   | Check-in time is after 12.00 Noon & Check-out time is before 11 a.m.   |
| 3   | Bill to be raised only for the State/ Govt Guest.  |
| 4   | The reservation is not transferable and is valid only if photo ID Card is presented at the time of check-in in log-hut. The customer should carry with him print-out of the Electronic Reservation Slip.   |
| 5   | The authority reserves the right to cancel any reservation under unavoidable circumstances.  |
| 6   | Maximum of two accompanying children below the age of 12 years will be allowed along with the parents/adults in the room.  |
